The facility has four coolers and cooled dock/repacking area of 24000 sq ft facility. There are a majority of conventional product handled on site with some organics. There are allergens on site with Eggs and yogurt. There are some prepacked items (precut) and juice handled on site. The facility is mostly a storage and distribution with some repacking of various items into poly clear bags in 3# and 5# per customer request. This is conducted on make shift pallets and limes observed on this date. All product is tracked via Thyme system a with date and invoice.
